

A. NOW THIS DEED WITNESSES :

WHEREAS the Founder/President of the Trust who is also trustee is inhabitant of the same vicinity having interaction with one another over social problems and hurdles touching the need of general Public at large and whereas after prolonged discussion they have sorted out that, light of general/professional education should be focused on all corners of the society to cater to the long felt desire of getting ideal education by the students at large to stand in their lives independently. Driven by the aforesaid urge and feelings the Trustees intend to start, establish, run and manage institutions touching different branches of education. This trust is a non-profitable & charitable trust.

Blossoming Angels Educational and Social Development Trust will abide by the Charitable Trusts Acts 1950 or any other relevant Acts through the President or Secretary of the Trust.

- B. The objects of the trust shall be as hereunder:
 - To promote and establish educational institutions for imparting education on Nursery, Secondary, Higher Secondary School under ICSE/CBSE/ West Bengal Board/Council, Technical Institutions, Technical campus with programmes like Engineering/ Technology, Pharmacy, Applied Arts and Craft, HMCT, Architecture/Town Planning, MCA, Management etc. Research, Hotel Management, Arts, Commerce, Science, Colleges based on medical grounds like – Paramedical, Nursing, Dental, Medical College etc., Social Welfare, Entertainment and also to setup professional education institutions and all teachers training college like - PGBT, B.Ed., M.Ed., D.El. Ed., B.P.Ed., M.P.Ed., etc.
 - To advancement and propagation of education and learning including establishment, maintenance and support of schools, colleges, institutions and other educational institutions.

- To make provision to advance the cause of and to impart nursery, primary, 3. secondary higher education, teacher's training, law, commercial, industrial, technical, film educational institute on Cine Media, Fine Arts, Culture and technology and its related subjects, Project work on film Making, Documentary, feature film with National and International standards, fine arts, sports, cultural and all or any other type or kind of education and training specially in the fields science, commerce, arts, management, business administration, engineering, medical, civil aviation, telecommunication, information technology, hotel management, fashion design, interior decoration, architecture, sports and culture etc. irrespective of caste, creed and religion.
- To establish, construct, acquire or taken on lease/license schools, colleges, staff quarters, boarding house, infrastructure facilities of any type and description as may be deemed necessary etc.
- To establish, construct, acquire take on lease/license and maintain boarding houses and practical rooms for students, faculty, staff etc.
- To hold, arrange and organize meetings, lectures, talks, discussions, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, debates, cinema, audio-visual programmes, the artistic performances and other cultural activities, sports and games.
- To participate or engage in social development work in association with Central Government/State Government/Local Governments/Private or Public Organizations to implement various schemes in Rural and Urban sectors.
- To acquire establishment, maintenance and support of libraries, museums and reading rooms and distribution of books etc. for advancement of education and knowledge in general.
- To enter into any collaboration, take franchisee or be affiliated to any other Educational Institution, College or University as may be deemed necessary.
- 10. Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time.
- To obtain affiliation of the course and degree of said educational institution from Indian Universities, Boards, Associations or in any name they are known or from foreign Universities, Boards or Associations or in any name they are known.

- To care for the mentally and physically handicapped person and distribute limps to them and to them and to arrange treatment and rehabilitation for the physically handicapped and drug addicted person.
- 13. To establish Oldage Home, short stay Home, day care centre for destitute women street children and orphanage and weaker and under privilege section at the society for their social security and justice without profit motive.
- To encourage grow more foods to use compost fertilizer and use of new method in agriculture.
- To construct village road, digging ponds to contra the floods construct embankment bridge, rural Hospital or health centre irrigation etc.
- To work in field at Public Health (i.e., Malaria, Kalazar, Diarrhea etc.), AIDS control Programme, Blindness Control and other health programme in the interest at the public service.
- 17. To provide Ambulance to the sick people to admit in the hospital for treatment and provide Ambulance for the sick animals to admit in the hospital for treatment as a charitable to extend of the capability of the trust.
- 18. To establish and develop tourism, cultural and research centres with all amenities to attract foreigners for economical and social development of the concerned areas and to make the area familiar globally. And for the purpose joint venture project may be executed in association with Central/State/ Local Govt. or Private/Public Organizations for betterment and modernization of such project.

C. The other objects of the Trust shall be:

 To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running schools, colleges, lecture halls and other establishments or institutions for advancement of education and of knowledge in arts, technical, medical, commerce, science, literature, humanities and all other useful subjects in all their manifestations.

- To promote, advance and encourage and/or aid in helping and awareness, promoting, advancing and encouraging nursery, primary, secondary and higher education, also physical training, teacher's training and training of handicrafts, SC/ST & OBC etc. film and fine arts, health, sports and other useful arts, crafts, among the public including the establishment and maintenance of Shilpa Shikshalayas, Kala Kendras and other welfare centres for them.
- 3. To foster and encourage education and training in handicrafts, fine arts among women folk in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts or otherwise, Centres and institutions for women and children and to provide social welfare works for women and children.
- To meet travelling, boarding and lodging expenses for students going abroad for higher commercial and technical education.
- 5. a) Gifts/donations either in cash or in kind, grants, contributions, aids bequests, legacies or any remittance in cash or in kind which may be made by any institutions, govt. or semi-govt. organizations, persons or members of the public or any one who is in sympathy with the aims and objects set out herein including any donations made for any such specified purpose or objects and gifted property whether movable or immovable in the name of the trust may be sold for attainment of the object of the trust subject to a valid resolution.
- b) Properties movable and immovable which may be acquired by the trust by purchase, exchange, lease, gift or otherwise.
- c) Income and profits from the properties of the trust including surplus if any from the activities of the trust.
- d) Any fees, charges, etc. as may be collected in the day to day activities of the trust or in the course of any public or private performance by artistes etc.
- e) Any income whatsoever shall be deemed to be a part of the trust property.
- 6. For the purpose of this Trust, the authors of the Trust delivers conjointly an amount of Rs. 10,000/- in the hands of the Trustees which shall be treated as "Trust Fund" and for this an advalerum stamp duty of Rs. 500/- is given herewith. The Trust has / had no other movable/immovable property except said Rs. 10,000/- (Ten thousand only) on this date of registration.

- E. The name of the Trust shall be styled as "BLOSSOMING ANGELS EDUCATIONAL AND SOCIAL DEVELOPMENT TRUST" This trust is a non-profitable & charitable trust.
- That the present number of trustees can be extended subject to decision to be taken
 by the majority of Trustees in a general meeting subject to prior written permission
 from the Founder/President to do so. Port folios (author/trustees) of the trust body
 may be changed in every year to be decided in a general meeting by majority
 members.
- That in case of trustee becomes adjudicated insolvent or becomes a lunatic or of unsound mind or tenders resignation or becomes convicted for any offence under Indian Penal Code, his or her office as a trustee shall be vacant and in such event trustees through presence of majority members shall be entitled by a majority vote to enroll further members to fill up those vacant posts subject to rules and regulations of the Trust.
- That in case of death of a Trustee, his/her authorized representative person shall be placed in his/her position after taking resolution by the trustee with 3/4th majority.
- 4. That the financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper.
- 5. That the Trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust Properties and of the trust decide the particular object or objects for which the income or corpus of the Trust Fund or Properties for the time being available shall be applied.
- That the Honorarium to be paid to the trustees out of the surplus arising from the operation as decided by all trustees and after demise of the trustee, nominees will automatically be operated in place of the demised person.

- 7. That all the trustees shall try their level best to make provisions for funds for attainment of the objects of the Trust and as such be entitled to accept donations, contributions, gifts either in cash or kind or in the nature of immovable assets as far as practicable and suitable for the development of the Trust.
- 8. That without affecting the generally of powers and functions of the trustees to manage and administer the trust, the Board of Trustees shall have the following functions:
- To borrow if needed against the security of the assets of the trust by way of bank over draft, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents, deeds papers, etc. as may be necessary in connection therewith.
- b) To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the Trustees by any two of the trustees to be nominated in this behalf by the Board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- c) To appoint or form or make provision for the appointment of a sub-committee of Trustees and/or formation of society, and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the Trustees may prescribe.
- d) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as the Board of Trustees may from time to time think fit and proper.
- e) To spend any portion of the corpus or the income of the trust fund for purchasing any land and/or constructing any buildings, for and in the name of the trust for purpose of carrying out promoting and/or executing any or all of the objects of the trust.
- 9. That the trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties.

...... Contd

- 10. That the trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force from time to time and to convert, vary, alter, dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in sub-section (3) of Section 13 of the Income Tax Act, 1961, or any subsequent amendments as may be made from time to time.
- 11. That in the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income Tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the trust.
- 12. That the trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and discharges for all money received by them.
- 13. That the trustees shall keep Bank account or accounts with any bank or banks, to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution two or more of the trustees jointly as per resolution / or by the person appointed by the Board of Trustees in this behalf to operate such account or accounts.
- 14. That the trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the Trust Fund and may carry out repairs required to be done to the same and keep the same insure against loss or damage by fire and may incur all other costs, charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the trust as they may in their absolute discretion think fit.
- 15. That the trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Faculties and other employees for the purpose of management of the trust to run the educational institute and supervision of the trust properties, for collection of rents and profits, for keeping the accounts and records and for other purposes of the trust.
- 16. That the trustees may establish their office at such place or places and may change such places from time to time as they may think fit.

..... Contd

- 17. That the trustees shall have full power to compromise or compound all actions, suits and other proceeding and settle all differences and disputes touching the trust Estate and/or the Trust Properties by referring any such differences or disputes to a sole arbitrator as per the provisions of arbitration and Conciliation Act, 1996 and any other statutory modification made thereafter.
- 18. That the trustees may from time to time frame schemes and rules and regulations to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.
- 19. That the receipts granted by the trustees or any one or more of them for any moneys, stocks, funds, shares, securities or investments paid, delivered or transferred to them in exercise of the trust or powers hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.
- 20. That the trustees may reimburse themselves and pay and discharge out of the TRUST FUND all expenses incurred by them in or about the execution of the trust or any of their duties under these presents including travelling expenses, but will not be entitled to any remuneration.
- 21. That all the trustees unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives.
- 22. That the number of trustees shall be not less than two.
- 23. That the surviving or continuing trustees may notwithstanding any vacancy in their board, act as trustees PROVIDED HOWEVER that if the number of trustees shall fall below two the minimum fixed by these presents, the trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.
- 24. That the 2/3rd trustees at a meeting shall form a quorum for any meeting of the Trustees.
- 25. That the TRUSTEES shall elect from time to time amongst them one President and he shall hold office for one financial year, unless he resigns or refuses to act as President or otherwise ceases to be trustee.

- 26. That all proceedings and questions and matters arising at the meeting of the TRUSTEES shall be decided by a majority of votes and only in case of equality of votes the President shall have a casting vote.
- 27. That in case of difference of opinion between the Trustees the opinion of the majority shall prevail and if the Trustees are equally divided in any matter, the President shall have a casting vote.
- 28. That the resolution taken as per Para Nos. 26 & 27 and/or any other resolution in writing circulated amongst all the Trustees and signed by a majority of the trustees present in India shall be as valid and effectual as if it had been passed at a meeting of the TRUSTEES duly convened and held.
- 29. The founder of the Trust will have the power and proper authority to appoint new trustee for better management of the trust vide valid resolution 3/4th of the trustee member.
- 30. The trust is entitled to apply for financial assistance in kind of term loan or working capital loan from nationalized/private bank for infrastructure development, working capital requirement and other development work of the trust subject to having valid resolution for the purpose and in that case President (Trustee No. 1), Secretary (Trustee No. 2) and Treasurer (Trustee No. 3) will execute the documentations and other formalities require to be complied for raising such loan or financial assistance. The land, building, deposits, certificates, mutual funds, shares/bonds of the trust or trustees may be offered as security in kind of equitable mortgage/mortgage/lien against such bank finance if required. And the trust will repay such financial obligation as per terms and conditions of the concerned financial institute on priority basis.
- 31. That the notice of the meeting of the TRUSTEES and all communications may be sent to the TRUSTEES at their addresses registered for the time being in the records of the trust.
- 32. That all meetings of the trust shall be held at such place and at such time as the Founder of the Trust in consultation with the majority of the trust members, shall decide from time to time, if required.
- 33. That a trustee who is unable to be present at a meeting of the TRUSTEES may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

- 34. That the minutes of the proceedings of every meeting of the TRUSTEES shall be entered in a book to be kept for the purposes and signed by the Founder of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted as such meeting.
- 35. No person being
 - i) an undischarged insolvent, or
 - ii) convicted of an offence involving moral turpitude
 - iii) of unsound mind or
 - iv) a minor shall be eligible to be a trustee.
- 36. That the power to appoint new or additional Trustees, but so as not to exceed the maximum number and to fill vacancies in the office of the trustees, shall vest in the continuing trustees or trustees.
- 37. That a person shall cease to be a trustee in any of the following events
 - a) if he dies; or
 - b) if he becomes bankrupt; or
 - c) if he becomes insane or otherwise become incapable to act; or
 - d) if he resigns his office
- 38. That on a new additional trustees being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the Trust Property shall automatically vest in him along with the other TRUSTEES for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed or writing.
- 39. That the Board of Trustees shall be entitled to sue in the name of the trust and may similarly be used in the name of the trust.
- 40. That the Board of Trustees may by a unanimous vote of all the TRUSTEES for the time being except the trustee proposed to be removed, remove and trustee, permanent or otherwise, form office after finding the trustees proposed to be removed quality of serious misconduct in relation to or concerning the trust estate or trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee or these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges leveled against him for his removal. And the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.

- 41. That the Trustees shall be entitled to apply for and acquire adequate plot of land from the Govt., Semi Govt. or Private party by way of deed of agreement, tenancy, lease, settlement hire donation and others in the name of the Trust and to run and manage the intended institution by way of bank and private loan from any nationalized bank or any private institution by way of bank or any individual and if required to keep deposit of cash, property, Govt. securities shares, debentures, fixed deposits and other certificates as security, subject to the liabilities of income tax laws and rules as amended up to date.
- 42. That the trustees shall be able to publish pamphlets, brochures or make advertisement of course material, structure of fees etc. through magazine, newspaper or T.V. broad casting hoardings etc. regarding the institution.
- 43. That the trustees may demise the immovable property or properties of the trust either from year to year or for any fixed term or for any term of years or on monthly basis at such rent and subject to such conditions as they deem fit and proper and also accept surrender of lease and may manage the property as they think proper.
- 44. The income and expenditure of the Trust shall be audited by a chartered accountant annually and each trust member shall have unfettered right to inspect the same.
- 45. Bank account in the name of the Trust may be opened at any Nationalized/ Private Banks to maintain savings, current, fixed/recurring deposits. And such accounts to be operated by the joint signature of President and Treasurer only and that can be modified time to time subject to valid resolution in the trustee board.
- 46. (a) That the trust may acquire or amalgamate with any society or trust having similar objects or object with the consent 2/3rd majority in a meeting of the Trustee Board.
- b) That the trust may open its Branch office any where in India to achieve the objectives more effectively with the consent 2/3rd majority in a meeting of the board of trustees.
- c) That in case of non-functioning of the Trust or Dissolution of the Trust the assets and funds of the Trust, if any, after meeting-up its debts may be transferred to a similar Trust or Society having similar object or objects, with the consent of 2/3rd majority in a meeting of the board of trustees and society will act under control of the trust.

- Clauses or conditions not specifically mentioned in this deed, shall be read and construed in the light of Indian Trust Act as amended upto date.






